By-law Number 3688-2018

BEING A BY-LAW TO APPOINT OFFICIALS AS MEMBERS OF COMMITTEES AND LOCAL BOARDS, AS REQUIRED FOR THE YEAR 2018-2019

WHEREAS the Municipal Act, 2001, as amended, provides under Section 5(1) that the powers of a municipality shall be exercised by its council, and under Section 5(3) provides that a municipal power, including a municipality's capacity, rights, powers and privileges under section 8, shall be exercised by by-law unless the Municipality is specifically authorized to do otherwise, and under Section 5(4) provides that Subsections (1) to (3) apply to all municipal powers, whether conferred by this Act or otherwise:

AND WHEREAS related Acts authorize the appointment of committees, boards and special bodies;

AND WHEREAS it is deemed expedient to appoint all committees and board memberships by by-law;

NOW THEREFORE the Council of the Corporation of the County of Perth hereby enacts that the county representatives on committees and boards for the year 2019, or until their successors are appointed, be as follows:

1. COUNCIL COMMITTEES:

"Council Committee" means any advisory or other committee, subcommittee or similar entity of which at least 50 percent of the members are also members of one or more councils or local boards.

a) LAND DIVISION COMMITTEE (under the Planning Act): Councillor Jim Aitcheson, Councillor Matt Duncan, Councillor Daryl Herlick, Councillor Rhonda Ehgoetz, and Warden Walter McKenzie

b) JOINT ACCESSIBILITY COMMITTEE: Councillor Todd Kasenberg

c) MUNICIPAL SHARED SERVICES COMMITTEE: Councillor Jim Aitcheson, Councillor Robert Wilhelm and Warden Walter McKenzie

2. EXTERNAL COMMITTEE:

“External Committee” means a committee of an outside organization to which Council appoints one or more elected or staff representatives.

- a) CANNABIS DRUG TASK FORCE: Warden Walter McKenzie, Councillor Rhonda Ehgoetz, Councillor Todd Kasenberg and Councillor Robert Wilhelm

3. LOCAL BOARD APPOINTMENTS:

“Local Board” means a municipal service board, transportation commission, public library board, board of health, police services board, planning board, or any other board, commission, committee, body or local authority established or exercising any power under any Act with respect to the affairs or purposes of one or more municipalities, excluding a school board and a conservation authority

- b) PERTH DISTRICT HEALTH UNIT: Councillor Daryl Herlick, Warden Walter McKenzie , Councillor Robert Wilhelm

- d) AGRICULTURAL WORKING GROUP: Councillor Matt Duncan; Councillor Rhonda Ehgoetz; Councillor Doug Kellum, Councillor Robert Wilhelm and Warden Walter McKenzie
